

NOTICE OF ELECTION

Elizabeth Park & Recreation District Election Elbert County, Colorado Tuesday, May 3, 2022

NOTICE IS HEREBY given that a regular election of the Elizabeth Park and Recreation District Office of Directors will be held on Tuesday, May 3, 2022, from 7:00 AM to 7:00 PM. The election is being conducted as a **mail ballot** election. At said election, the electors of the District shall vote for one Director to serve the following terms of office on the Board of Directors of the District:

Electors of the District shall also vote on a ballot measure. For specific ballot measure language please contact Elbert County Elections for a sample ballot.

Ballots will be mailed beginning the week of April 11 to eligible electors. Ballots must be returned to the Clerk and Recorder no later than 7 PM on Election Day (Tuesday, May 3) in order for your votes to be counted. Voters can return their ballot by mail or by dropping it off at any designated ballot drop-off location or Voter Service Center. One Voter Service Center will be available for those who would like additional assistance or prefer to vote in-person. See below for Vote Center hours/days of operation. Ballots received after 7 PM on Election Day will not be counted. Postmarks do not count as a received date. Adequate postage must be applied.

If you need to register to vote or update your registration, please do so at www.govotecolorado.gov. The Elbert County Elections Division recommends all voters review their information to ensure their mailing address is correct.

If you make a mistake, damage, or lose your ballot, you may request a replacement by emailing elections@elbertcounty-co.gov or calling 303-621-3127 by April 25, 2022, or by visiting a Voter Service Center during the hours/days of operation listed below.
