**WHEREAS**, pursuant to C.R.S. § 30-28-117, the Board of County Commissioners of any county which enacts zoning regulations shall provide for a Board of Adjustment of three to five members and for the manner of the appointment of such members; and

**WHEREAS**, the Board of County Commissioners of Elbert County enacted the Elbert County Zoning Regulations on or about August 25, 2010; and

**WHEREAS**, pursuant to Part I, Section 3 of the Elbert County Zoning Regulation, the Board of County Commissioners of Elbert County is authorized to appoint members of the Elbert County Board of Adjustments, whom shall be a resident of the County; and

**WHEREAS**, the Board of County Commissioners have determined that there is a sufficient need to appoint members to the Elbert County Board of Adjustments, pursuant to C.R.S. § 30-28-117 and Part 1, Section 3 of the Elbert County Zoning Regulations, to fill vacancies.
