RESOLUTION NO. 14- 07

A RESOLUTION APPROVING ELBERT COUNTY VOTING PRECINCT MAP

WHEREAS, pursuant to C.R.S. § 1-5-101, subject to approval by the board of county commissioners, the county clerk and recorder of each county shall divide the county into as many election precincts for all general, primary, and congressional vacancy elections as is convenient for the eligible electors of the county; and

WHEREAS, pursuant to C.R.S. § 1-5-101.5, the county clerk and recording of each county of the state shall use a precinct numbering system in numbering election precincts established in accordance with C.R.S. § 1-5-101; and

WHEREAS, the Elbert County Clerk and Recorder has divided the County into fifteen (15) election precincts in accordance with C.R.S. § 1-5-101; and

WHEREAS, the Elbert County Board of County Commissioners hereby decides and determines to adopt the new precinct lines as presented by the Elbert County Clerk and Recorder to be effective upon the date of adoption of this Resolution.


